

Myrtle Trace Activities Committee Report
Monday - April 13, 2015

The meeting was called to order at 7 P.M. by Pat Paxson.

Pat Paxson welcomed new members Kathy and Bill Cain.

The minutes from the March meeting were reviewed and a motion was made by Cathy McElroy and seconded by Liz Maass to accept the minutes as written. All were in favor.

Charlene rose handed out the Treasurer's Report: Current balance is \$2,187.08. Total income for March was \$1,131.00 and expenses were \$510.34. Available funds are \$2,319.05. Charlene reported that of the \$2,319.08 available funds, currently \$132.00 is for BBQ Dinner reservations, which is available for the BBQ Dinner expenses. \$2,187.08 is available. It was discussed that this event is catered, along with beer, wine and water. Local businesses supply door prizes and a fee is also charged to those attending. The motion was carried and all were in favor.

Liz Maass made a motion to encumber \$150.00 for the Lasagna Dinner, the motion was seconded by Diane McDonough, all were in favor.
