# Myrtle Trace Activities Committee Report

The meeting was called to order at 7:00 p.m. by Santo Perry.
Debbie Rebocho asked if there were any new attendees. John and Donna Nyahay introduced themselves to the Committee.

Santo Perry asked if everyone had reviewed the Minutes from the January 10, 2022. Pat Paxson made a motion to accept the minutes, seconded by Fred Shields and carried.

The Treasurer's Report: Cathy Smith reviewed the report and advised that the current balance $\$ 1,998.53$. Jeanne Niziol questioned the $\$ 250$ for closet supplies and why the amount never changed. Cathy Smith explained that the $\$ 250$ was a constant figure. If there were supplies purchased, the checks would be listed on her report. Pat Paxson explained that the amount is a consent amount and does not change. Pat Passon made a motion to accept the Treasurer's Report, seconded by Geralyn Hartman ad motion carried.

## Standing Committee Report

## Old Business

## New Business
