# Myrtle Trace Activities Committee Report <br> Monday - March 14, 2022

The meeting was called to order at 7:00 p.m. by Bob Smith.
Debbie Rebocho asked if there were any new attendees. There were no new members.

Geralyn said she would contact Publix and Dollar General. Deb Weirman said she would contact Coastal Ale House. Debi suggested that perhaps we could ask each Phase to create a basket/contribution. Susan Granger stated what about going to each of the Groups in the Community. There was a discussion with regard to this. Jazz in the Park: Bob Smith advised that the Band is set for August $7^{\text {th }}$. Debbie Rebocho stated that Kurbside Catering has also confirmed. There was discussion with regards to the ice cream truck. At the last meeting, Anne Kongvold said she would look into this.

## New Business

Memorial Day: Bob asked if there was anyone who would like to chair this event. Debbie Rebocho said that she would discuss it with Herman and see if he would.

How to Pay for Band/Entertainment: Bob Smith stated that he had prepared a form to use. Bill Fox advised that the best way to handle it is to have a contract with the group. Bill stated there should be a cancellation date. Bob advised that is right. There was a discussion.

Veteran's Day: Bob Smith advised that Harry Caldwell had volunteered to chair the event. Susan Granger stated that at one of our meetings Ken Weirman had volunteered to chair the event. There was a discussion with regard to this.

New Year's Eve: Geralyn Hartman advised that she spoke to the Doo Wop band, and they will hold New Year's Eve for us. Arlene Buckley stated that everyone who has heard this group has asked her if they can come back for New Year's Eve. Debbie Rebocho stated that it is too early to discuss New Year's Eve as there are other events that need to have money encumbered. Bob Smith also stated the same. If we lose the group, we will have to solve the problem.
