MYRTLE TRACE HOMEOWNER'S ASSOCIATION ANNUAL MEETING, HORRY GEORGETOWN TECHNICAL COLLEGE FEBRUARY 3, 2024

Nancy Seeds, President of the Board of Directors, called the meeting to order at 2:00 p.m.

Nancy Seeds asked everyone to please rise as Dusty Rhodes leads us in the Pledge of Allegiance.

Please give your attention to Dusty Rhodes as he gives our invocation. Dusty will also read the names of our Myrtle Trace friends and neighbors who passed away during the past year and January of this year.

A quorum was confirmed by Susan Granger who announced the candidates for the At-Large Board of Directors position. They were Ted Black and Larry Lapinski. Susan asked if there were any nominations from the floor; being none, nominations were closed and voting was held.

Contractors are: Cathy Smith – Accounts Payable, Jean Hohenberger – Accounts Receivable, Debi Perry – Association Administrative Advisor, Jean Niziol - Property Committee Secretary, Terry Eisenhardt – ARC Secretary, Carol Blonowicz – "News and Views" Coordinator, Nancy Southard – Directory Coordinator and Diane Gascoigne – Board Recording Secretary.

TREASURER'S REPORT: Annual Treasurer's Report FY2023

I've ended each of my monthly reports throughout the year telling you "We are in good financial shape." If you look at the budget comparison that is included in the annual packet you'll see negative numbers at the bottom of the 2023 Actual Column. To anyone here who is familiar with fund accounting, this report will seem like an oversimplification, but allow me to explain: we keep your money in two different cost centers, Operating funds and Reserve funds. You pay your dues, and the money goes into our operating account; we pay the bills out of that operating account and anything left over goes into our reserve funds.

Because not all homeowners' associations are as transparent as we are, the state requires us to report these two cost centers the same way - income and expense for the year. And we must show that we have plans for the reserve funds; we're not just squirreling it away. The monthly treasurer report also lists the designated fund totals to which the reserve funds are allocated. The operating account is straightforward – income for the year (your dues) expense for the year (paid liabilities and bills). Any excess is member equity and you see that number on the balance sheet; money that is headed for the reserve fund. The reserve fund is reported the same way - income for the year, which is minimal because the only income going into the reserve fund for the reporting year is interest from our CDs; and expense for the year which is spending for special projects like the Berry Tree Lane and Myrtle Trace Drive to Berry Tree Lane road resurfacing, as well as infrastructure and replacement of capital items which this past year included pond dredging, diffuser installation and ramp construction. The reserve fund expense for the reporting year is greater than income yielding a negative number. We move the excess funds from the operating fund into the reserve fund after we've taken care of our obligations for the year. The funds won't go into the reserves until February or March of the following year and so will not show up in the current reporting year. We combine these two cost centers which is what the balance sheet shows. At year end our operating fund had a very healthy balance of \$263K and our reserves

show a balance of \$535K. Our job as a board is to manage your money and I believe we have done that. Over the past year we have moved much of the reserves out of low yield CDs into higher yield items and have paid for several large cost items.

I am not alone in my job as – I have excellent help – Jean Hohenberger collects the money; Cathy Smith pays the bills; Debi Perry oversees the books and to keep us straight we have an annual audit. In closing – we started the year with 858K on our balance sheet and we end the year with more than 928K. Thanks to all of you for paying your dues – which allows us to take care of business. Thank you for allowing me to serve on your Board – it's been a pleasure working for you; thank you for trusting me to be President – it's been a pleasure working with you. And as I begin my

life sentence as a past president I'll leave you with this thought – I wish you all good health, good times, and good friends. And I hope I can be counted among them.
