### **APPROVAL OF MINUTES:**

She also asked the price for removal which Liz did not know. This item will be tabled until the next Board meeting when the price is known for removal of the tree.

Pat Paxson moved and Nancy Southard seconded the motion to accept the Property report with the caveat that the tree removal on Candlewood Drive be addressed again next month. The motion passed unanimously.

Nancy Southard questioned the water usage for the clubhouse and asked Liz to look into it. The cost has gone up and yet we are not using the clubhouse. Perhaps there is a leak. Liz requested money for street signs again.

COMMUNICATIONS COMMITTEE - Ted Ackley had nothing to add to his report. .

Mary L'Heureux moved and Pat Paxson seconded the motion to accept the Communications Committee report as written. The motion passed unanimously.

**TREASURER'S REPORT** – Pat Paxson gave the treasurer's report. She said YTD income is ahead of budget. Jim Luneke said as of yesterday the Myrtle Trace tax preparation has begun.

Nancy Southard moved and Pat Paxson seconded the motion to accept the Treasurer's report. The motion passed unanimously.

### **OLD BUSINESS:**

Clubhouse and pool restrictions are still enforced as the virus is climbing locally. - Donna Ebling said she appreciates most everyone's patience. We are monitoring this on a month-to-month basis. Santo Perry said the 4th of July picnic will be cancelled as restrooms will not be available for use in the clubhouse.

#### **NEW BUSINESS:**

Run-off Elections – Donna Ebling said the clubhouse will be closed (use of library and copier) on June 23, 2020, for the run-off election.

Budget 2021 – All committees are requested to submit their 2021 budget proposals to the Board no later than August 19, 2020.

**Hurricane Season** – Donna Ebling said the lakes are being kept as low as possible. When we know a hurricane is coming please place all your yard items inside and remind your neighbors to do so before they travel. Be prepared. The Board will be providing residents with a "cheat sheet" for hurricane preparedness.
