**CALL TO ORDER:** The meeting was called to order by Donna Ebling at 9:02 a.m.

- Donna Ebling read two emails sent to her. Ellen Elliott emailed her support in keeping the clubhouse closed. Joe
  Martin emailed that several people in Myrtle Trace have contacted the virus. He applauds the Board for keeping
  the clubhouse and pool closed.
- Arlene Buckley said her doctor told her the water in the pool would kill the virus. Residents should have the choice of using the pool or not.
- Geralyn Hartman wants the pool open.

#### **APPROVAL OF MINUTES:**

Bill Fox moved and Nancy Southard seconded the motion to accept the June 17, 2020 Board minutes. The motion passed unanimously.

**ACTIVITIES COMMITTEE** – Santo Perry asked the Board for permission to have the planned Ice Cream Social on August 8, 2020 from 2:00 - 4:00 pm. outside by the Bocce Ball Court. A "Mr. Softee" ice cream truck would be available. No one would be allowed in the clubhouse and if residents just came for ice cream and left there would be no need to have

restrooms available. He said there would be a limit on the number of people in attendance. Donna Ebling said the Board will discuss this and let him know.

Nancy Southard moved and Mary L'Heureux seconded the motion to accept the Activities Committee report as written. The motion passed unanimously.

**ARCHITECTURAL REVIEW COMMITTEE** – Pat Hosford said there is one agenda this month. She also gave the Board her committee's budget for 2021.

Pat Paxson moved and Mary L'Heureux seconded the motion to accept the ARC report. The motion passed unanimously.

**PROPERTY COMMITTEE** – Liz Maass once again requested permission to have the remaining street signs made. They would take \$2,000.00 from their budget from an area they have not used this year. Liz said the county will be spraying for mosquitos in Myrtle Trace sometime this week. Don't be outside and don't let your pets out. She also gave the Board a copy of a request for tree removals on common ground. There was much discussion over what actually needed to be done to one tree. The total cost for the removal of all trees would be \$2,300.00.

Nancy Southard moved and Pat Paxson seconded the motion to approve the removal of the trees for a total of \$2,300.00. The motion passed unanimously.

Pat Paxson moved and Mary L'Heureux seconded the motion to accept the Property report as written. The motion passed unanimously.

**COMMUNICATIONS COMMITTEE** – Ted Ackley had nothing to add to his report.

Pat Paxson moved and Mary L'Heureux seconded the motion to accept the Communications Committee report as written. The motion passed unanimously.

Donna Ebling said the Board wishes to thank all the "News and Views" carriers as they had an extra item to deliver this month with the Hurricane booklets.

**TREASURER'S REPORT** – Pat Paxson gave the treasurer's report.

Mary L'Heureux moved and Bill Fox seconded the motion to accept the Treasurer's report. The motion passed unanimously.

Nancy Southard moved and Bill Fox seconded the motion to keep the clubhouse and pool closed. One member abstained. The motion passed with the rest of the Board voting for closure.

## **NEW BUSINESS:**

ARC Proposal Regarding Front Patios – This proposal would be an addition to the ARC Guidelines. Pat Hosford shared information on the dimensions and materials to be allowed. Comments, questions or concerns regarding this proposed policy can be made during resident participation.

Nancy Southard moved and Pat Paxson seconded the motion to accept the ARC Proposal regarding front patios to become part of the ARC Guidelines. The motion passed unanimously.

- Mailbox Plantings and Updated Guidelines Donna Ebling said as it stands now if you want to plant something around your mailbox you must ask for Board permission. There is a new policy which Donna read and it will be printed in the next "News and Views" as well. It will be voted on at the next meeting. Comments can be made during Resident Participation if there are any.
- **2021 Budget** Committees are requested to submit their 2021 budget proposals to the Board no later than August 19, 2020.

- Herman Rebocho made more comments on reasons for keeping the pool closed.
- Santo Perry said the Activities Committee would keep attendance at 150 people for the Ice Cream Social. It would be first come, first serve.
- Pat Hosford gave a moving speech thanking all the committee volunteers. She thanked Santo Perry and the Activities Committee for all they have offered and made available to the community in the past. She thanked the ARC Committee for all that they do and the abuse they sometimes have to bear. She thanked Liz Maass and the Property Committee for all their work. She said the first thing most of us think when we turn into Myrtle Trace off Highway 501 is, "Oh, I'm home and it's a beautiful place."
