APPROVAL OF MINUTES:

ACTIVITIES COMMITTEE: Santo Perry informed us that the upcoming Pot Luck Dinner and Rock and Roll with the Oldies have been cancelled due to Covid. The next scheduled event is St. Patrick's Day.

ARCHITECTURAL REVIEW COMMITTEE – Pat Hosford said there is one agenda for review due to Christmas. She also gave the Board a copy of the annual homeowner request form which shows all projects submitted to ARC for the year and reviewed by the committee.

Mary L'Heureux moved and Nancy Southard seconded the motion to accept the Property Committee Report as written. The motion passed unanimously.

COMMUNICATIONS COMMITTEE – Ted Ackley again recognized Gary Main who delivered the "News and Views" for several years and is stepping down. Phoebe Lee has agreed to take over his deliveries.

Mary L'Heureux moved and Nancy Southard seconded the motion to accept the Communications Committee Report. The motion passed unanimously.

TREASURER'S REPORT – Nancy Southard said 2021 ended on a good note. The Board had estimated that 36 homes would be sold in 2021; 43 homes were actually sold. For each closing the Association receives \$500.00. The Association received \$3,500.00 more than anticipated. Dredging has been postponed until the new lake contractor can look at the ponds and make an assessment. Money has been put into a savings account for dredging for future use. Nancy said when the Board builds the budget we plan for excess revenues and they are placed into our reserve funds "our

designated funds". We have sufficient excess funds this year to contribute to our reserve funds. Myrtle Trace is on solid ground.

Activities Committee Guidelines for Hosting an Activity – The Board has determined that the change to the guidelines regarding a "no refund policy" was presented but not app-roved. Santo Perry must take this back to the Activities Committee and then resubmit to the Board. Then it will be posted in the "News and Views" and voted on at the next Board meeting.

- ➤ Increase for Mailbox Replacement to \$17.00 The price of mail boxes has gone up; hence, we have an increase from \$12.00 to \$17.00.
- Mask Wearing Due to the Omicron variant of Covid and so many people in our community being sick with Covid, the mask mandate for the clubhouse has been reinstated.
- > Concealed Carry/Open Carry Weapons prohibited in the Myrtle Trace Clubhouse and Recreational Areas (SIGNS WILL BE POSTED)
- New Auditor Search is Now Underway We have just received our 2020 audit after Christmas. We need someone who is more efficient.

MEETING RECAP:

- Pat Hosford asked about the increase for mail boxes. She said all policies have to be submitted to the Board, go into the "News and Views" and then be voted on, why does this one not have to?
