RESIDENT PARTICIPATION:

Diana DeFeo asked that an area in the parking lot on Cricket Court be repaved. It suffered some damage when the sidewalk in front of the town homes was repaved. APPROVAL OF MINUTES:

ACTIVITIES COMMITTEE: Bob Smith said the Activities Committee did not meet in July as usual but they meet tomorrow night. All scheduled events are still on and the committee has a few new ideas they are pursuing.

TREASURER'S REPORT – Nancy Seeds said Myrtle Trace is on budget for the third quarter of the year. She also said home sales have slowed down now. A lot of projects were completed and paid for. We are in good standing.

Bob Ebling moved and Sue Granger seconded the motion to accept the Treasurer's Report as written. The motion passed unanimously.

OLD BUSINESS:

➤ **Policy on Truck, RV and Camper Parking -** Bill Fox said the policy for this was printed in the last issue of "News and Views" and now needs to be voted on.

Nancy Seeds moved and Bob Ebling seconded the acceptance of the new policy regarding truck, RV and camper parking. The motion passed unanimously.

NEW BUSINESS:

Resignation of Administrative Consultant - Bill Fox read a Letter of Resignation from Jim Luneke. Jim will be resigning as of April 1, 2023 giving him ample time to train the new consultant. Bill Fox told Jim how much the Board appreciated all he has done for our community through his service. It is a tough job.

Nancy Seeds reluctantly moved and Bob Ebling reluctantly seconded the approval of Jim Luneke's resignation as Administrative Consultant to the Board. The motion passed unanimously.

Administrative Consultant Position - Bill Fox said the position for Administrative Consultant will be posted in the next issue of the "News and Views".

CORRESPONDENCE: The Board received a thank you note from Catholic Charities for Karen Garcia.

MEETING RECAP:

Debbie Rebocho asked the Board, with regard to the new policy for parking in the clubhouse parking lot, could the people on the camera committee be notified when someone will be parking in the lot so the camera can be angled in the correct direction. She also asked that if the vehicle leaves the lot and comes back, it be parked in the same spot.
