

## REVISIONS TO POLICIES/GUIDELINES Policy on Renting Homes:

For various reasons, owners of property located on Myrtle Trace may wish to rent their property in lieu of occupying their property. Should such an event be initiated by the property owner, the Association's Accounts Receivable Consultant will require the owner to request and complete an Owner/ Tenant Registration Form and Agreement. This form must be completed prior to the date of commencement of each new lease agreement. It is the owner's responsibility to provide a copy of the Declaration of Covenants, Conditions, Reservations and Restriction for the Myrtle Trace Homeowners Association, Inc. as amended, its Bylaws, rules, regulations, Association policies and procedures to include Property and Architectural Guidelines. The minimum length of time a home may be rented and/or when a rental agreement is renewed is ONE year. Once completed, this form is to be returned to the Accounts Receivable Consultant prior to the move in date. Failure to deliver the completed agreement as instructed within the form will result in the property owner being assessed a fine in the amount of \$500.00. Additional such fines, in equal amounts, shall be assessed against the owner for succeeding monthly periods at the close of which the required agreement has not been submitted. (Revised and Adopted Effective March 18, 2020).

**The policy revision is in bold print.** [The Owner/Tenant Registration Form will state the minimum to comply with policy.]

#### **Check List For Cleanup and Maintenance of Clubhouse:**

1. All clubhouse dishes, cups, glasses, bowls, utensils, pans, coffee pots, etc., that have been used for your event are to be washed, dried and items placed where they were originally stored, the same day as the event. Dishwashing pan and detergent are under the sink".

The policy revision was deleting the term "dishwasher" since there is no longer a dishwasher in the clubhouse kitchen.

**PLEASE NOTE:** The proposed revisions were published in the March issue of the *News & Views*. The approved revisions are being published in the April issue of the *News & Views* making the changes enforceable and in compliance with the Board Policy on Publication Notice.

All policy revisions and/or amendments will be printed for updating the MTHOA Guidelines & Policies notebook in January 2021 and distributed with the Annual Meeting Packet information. In the interim, the information here will serve as the updated information.

#### Guidelines For Hosting An Activity -

Item #8 Refund Policy currently reads: "Refunds must be requested at least 7 days prior to event unless "extreme emergency" exists. Flyers should reflect this to remind attendees of this policy. The proposed change was <u>removal</u> of the phrase "unless "extreme emergency" exists. **The proposed change was discussed and action on the proposal was tabled until the April Board meeting.**
