BOARD ACTION TAKEN

SYSTEM OF FINES FOR COVENANT AND NON-ARCHITECTURAL GUIDELINE VIOLATIONS:

The Master Declaration of Covenants, Conditions Reservations and Restrictions of the Myrtle Trace Homeowners Association, Inc. states the specific purpose for which it is formed is to provide for the maintenance and preservation of the community.

The Board of Directors is required to enforce compliance with rules and regulations and other policies enacted in accordance with the governing documents of Myrtle Trace. These include, but are not restricted to, Section VII of the Master Declaration and to The Architectural Review Committee Homeowner's Guidelines.

The following document outlines the fine system for Covenant and Non-Architectural Guideline violations and offers an appeal process that affords the homeowner the opportunity to bring any violation into compliance without penalty.

Non-architectural violations of Article VII and Non-Architectural Homeowner's Guideline violations shall be subject to a \$100 fine if not corrected within 24 hours of notification and an additional fine of \$25 per day until the offense is remedied.

Discontinue the Truffle color for house paint. Current owners will be grandfathered in. New owners and resales will not be offered this color.

PROPERTY COMMITTEE (Cont'd) FIRE ANTS

For those of you who have just moved to the South, we have Fire Ants. Their bodies are a redish brown. When we get a flash flood or heavy rains, the ants move to the surface. You can see the mound with a hole in the middle and ants scurrying about.

A fire ant sting often begins with an intense pinching or burning pain immediately after the sting. This pain is short-lived, lasting anywhere from a few seconds to a few minutes. Next comes itching and/or continued burning that may be mild or intense. Itching tends to get stronger over the next few days. Most stings heal on their own without treatment.

Fire ant stings also produce a mark that sets them apart from other insect stings. The wounds are pusfilled blisters that are round and may look like pimples. As fire ants attack as a group, stings often come in clusters. Blisters appear quickly, usually within 20 minutes of the attack. The blisters that develop after fire ant stings are allergic reactions, but some people develop more severe reactions. The areas immediately surrounding the sting may swell, burn, or itch. Anaphylaxis is less common, but can be life-threatening. People with severe allergies to fire ant venom typically develop symptoms within a few minutes after being bitten.

The following symptoms need emergency medical help: Trouble breathing, dizziness, swelling of the tongue or throat, confusion and loss of consciousness. If left untreated, these allergic reactions can cause the body to go into shock.

Fire Ant Sting Prevention

Stay away from fire ant nests. Be careful when you mow the lawn or work in your yard. Wearing protective clothing like thick socks and boots while working outdoors. Wear gloves. Avoid work in or around fire ant mounds. Move out of area immediately if bitten by a fire ant or if fire ants are found on the body. If you are near water, hose yourself down. Use insect repellents designed to deter fire ants.


