## **BOARD BRIEFS**

**SAFETY ON MYRTLE TRACE ROADS**—In previous issues of News and Views, the Board has identified safety concerns for our community roads. Unfortunately, incidents placing our residents in danger have not been reduced. In fact, more incidents have been reported.

Most recently the board has received a written complaint about dangerous and illegal behavior on Myrtle Trace Drive. A driver ignored a stop sign, nearly collided with the complainant, and then blatantly ignored 2 subsequent stop signs as he made his way to his home. We have also received 3 complaints detailing unacceptable behavior by a resident who resorts to inappropriate language and has passed drivers on Myrtle Trace Drive. In one instance the Board has a record of the license and address of the offender. In another, we have a detailed description of the vehicle and driver.

We are no longer simply advising that additional care be taken along our roads. We are insisting upon it. The Board will review and discuss the incidents and compliance with stop signs and speed limits. Enforcement measures are also being explored.

It is most unfortunate that the aberrant behavior of a small group of residents imperils the safety of the entire community. However, the Board will act to make sure the safety of the community is upheld.
