Nancy Southard, President of the Board of Directors, called the meeting to order at 2:00 p.m.

Nancy introduced the five individuals who the Myrtle Trace Homeowners Association has contracts with: Terry Eisenhardt, Secretary for ARC; Diane Gascoigne, Recording Secretary for the Board; Ted Ackley, Accounts Payable; Peter Bevan, Accounts Receivable; and Jim Luneke, Administrative Advisor.

Nancy introduced the chairpersons for each committee: Pat Paxson, Activity; Pat Hosford, ARC; Ted Ackley, Communications; and Richard McEvoy, Property.

NOMINATING COMMITTEE REPORT:

At this time I would like to call on Renzo Falcinelli, our Vice President, to give the Nominating Committee Report. Renzo Falcinelli, Vice President of the Board and Chairperson of the Nominating Committee, introduced Donna Ebling and Herman Rebocho, the nominees. He thanked them for agreeing to run. After a call for nominations from the floor and hearing none, nominations were closed. The members then cast their ballots.

Nancy: Thank you Renzo. At this time we will continue our meting while the nominating committee is doing their work.

BUSINESS ITEMS: Before we start I am asking you to please identify yourself when you make a motion or second a motion by giving your name and address.

TREASURER'S REPORT:

During my presentation at last year's annual meeting, I made a plea that we would not have any major catastrophes during 2017 as we had with hurricane

Matthew in 2016. Thank goodness that plea was heard and as a result, our finances as we enter 2018 are very strong.

In your Annual Meeting Packet, which you have had for several weeks, there is detailed financial information for your review. Since these involve a lot of

numbers and financial data, I will not be reviewing these in detail, but may address a couple of items.

It is important to note that both the Board of Directors and our committees do our best to ensure the proper and wise handling of funds. Monthly revenues and

expenses are closely monitored to make sure we act in accordance with the yearly budget. All projects are carefully considered on a cost versus benefits basis.

Planning a yearly budget is one of the most important and time consuming functions that the Board undertakes. I know that you are all glad to see that the

budget for 2018 does not include any dues increase. As we planned, we were able to put money into both our Road Resurfacing and Repair and Replacement

Funds in the late fall of 2017, which had been delayed from the normal January to February timeframe.

Additional good news is that because of our strong financial position entering 2018, we will be able to make contributions to a number of funds to position us

for the upcoming and future needs. These include funding again the Road Resurfacing and Repair and Replacements set asides, money for Lake Renewal or

Dredging, Infrastructure and Emergency or Disaster Funds. By taking these steps we are establishing a firm foundation for the future. This does not mean we

will not have challenges to face, with Lake Renewal, along with Road Resurfacing, being our two most ongoing and expensive endeavors. However, with

our continuing to set aside funds on a yearly basis, we should be able to handle these needs.

In closing, I want to thank the Board and each of you, for allowing me to serve on the Board for these past three years and to be your Secretary/Treasurer for

the last two of those years. I consider it a privilege and honor to have done so. Thank you and God bless you and the United States of America.

Nancy: Thank you Darryl - I will entertain a motion to approve the Treasurer's Report

A motion was made by Bill Gascoigne and seconded by Ron Grove to accept the Treasurer's report. The motion passed unanimously.

Nancy introduced Liz Maass, who was standing in for Pat Paxson, to give the Activity Committee report.

Liz Maass: Good afternoon. It has been my pleasure to have served as the Myrtle Trace Activity Committee Chairperson for the last year. We have a dedicated group. We can be described by what is being felt in this room, Euphoria. Excitement, Uplifting, Physical, Helpful and Healthy, Organized,

Righteous, Inspiring, Active.

Our Officers are:

Chairperson - Pat Paxson

Vice Chair - Liz Maass

Secretary - Jeanne Niziol

Treasurer - Lisa Vawter who replaced Charlene Rose and is doing a marvelous job.

The Activity Committee has put on 16 special events and 50 or more weekly, bi-monthly, monthly, and every other month activities for the Myrtle Trace

Community. We hope you have enjoyed the ones you have attended. We wish to invite you to attend our meetings on the 2nd Monday of the month.

At this time I would like to have all committee members and those who assisted with activities to stand and be recognized.

Nancy introduced Pat Hosford, Chairperson of the Architectural Review Committee.

Pat Hosford: The Architectural Review Committee has had another busy year thanks to all of you who submit your project request forms to us for our review.

We reviewed 235 homeowner requests and 159 tree removal requests. Of the tree requests, 148 were approved for removal, 11 were denied and we asked for

32 to be replaced.

As you may or may not have noticed the recent storms (ice storms in 2014 and 2015 and the hurricane in 2016 have really decimated our big pine trees. Many

people will say that that is a good thing to get those trees down, but in reality it is not. These trees are what make this community unique. People seeking

homes can purchase property in any number of communities that have been clear cut, but there are very few with mature trees. In addition, each of these big

pine trees drinks thousands of gallons of water a year and is a huge factor in controlling surface water in the community. We realize we will not have these

trees forever, so we have begun asking homeowners to replace trees with trees of substantial size when a tree is removed. This year we have asked for the

replacement of 32 trees and we are in the process of reviewing our records to see if this has been done. So, if you have been asked to re-place a tree and have

not yet done so, please make that a spring project.

ARC has also revised their guidelines this year and several changes were made. This revision was included in the notebook distributed to you by the Board of

Directors this past November.

I want to take a minute to thank the members of the 2017 ARC and ask them to stand and be recognized for their service. They are: Diane Connelly, Joe

Griggs, Mickey Jarossy, Jenny Jenemann, Anne Kongvold, Kathy Lyle, Dianne McDonough, Kathryn Pears, Ron Petti, and Jack Touhy. Jenny Jenemann is

the Vice Chair and fills in very capably in my absence. Terry Eisenhardt is our secretary and prepares the agendas and the approval letters. Special thanks to

Terry McTarnaghan and Santo Perry our BOD liaisons who faithfully attended our meetings. Thank you to all who give of your time in service to this

community. Your willingness to volunteer is what sets this community apart and makes it

The News & Views is still the primary source of current information about our community. It reaches every resident and every homeowner including those

who don't live here. An e-mail version is also available to anyone who wishes to receive it. If you would like to be added to the e-mail list just give me a call

or send me an e-mail. You will still receive your paper copy. The January 2018 issue consisted of 18 pages - the largest issue ever published.

Susan Lyons is the Webmaster of and Bruce Williams provides all the photos and technical support. I provide back-up for Susan. It contains a vast amount of

useful information: Minutes of Board meetings, Annual meetings and committee meetings for the past 6 years are available. Photos of the Board members and

committee members are displayed. News & Views issues for the past six years may be seen. A very useful feature of the site is a listing of contractors and

service providers who have been recommended by Myrtle Trace residents. This listing is found under Homeowner Resources.

Whenever you see the Myrtle Trace flag lowered, a resident has passed away. The name of the deceased may be found under In Memoriam and it will also be

posted at the Clubhouse entrance. Our covenants, policies and procedures are published in full with an easy-to-follow index. Finally, the website is a great

way to tell your family and friends back home about the great community you live in.

Our official greeters, Bonnie Longnecker & Pam Reinhart, visited 60 new families or individuals during the past year compared with 41 visits during 2015

and 47 visits during 2016. That reflects a significant increase in the resale of homes.

Other members of the committee are Lina Janovitz who maintains our Community directory database and also mails the News & Views each month to about

36 non-resident homeowners. Jeanie Rhodes edits the News & Views fliers and Pat Paxson prepares and maintains the community calendar which is found on

the back page of the News & Views each month. She also handles private reservations for the

use of the Clubhouse. Cecile Britt manages the outdoor Clubhouse bulletin board. Jon Bourne maintains an emergency e-mail database which is used ONLY

when there becomes an urgent need to contact as many of our residents as possible. In addition to serving as Chairman of the Communications Committee,

I've been the Editor of the News & Views for the past 23 years.

Our News & Views carriers are Bill Alexandra, Charlie Conklin, Tom Gayer, Jean & Joe Glavan, Bob Kirk, Thor Kongvold, Gary Main, Sheilah Reynolds,

Nancy Seeds and Dot Thompson.

I would like to thank all the committee members and the news carriers for their valuable service. They all do a great job.

PAST PRESIDENTS' REPORT:

Nancy introduced Mary Johnsen, the Chairperson of the Past Presidents' Council.

Mary Johnsen: As Chairperson and on behalf of the Council of Past Presidents, I'd like to share with you what our Committee does and how we were able to

assist the current board and our community in 2017.

Our mission statement declares: We are here to serve as a helpful resource to the Board of Directors and to tap into the corporate memory of our members as

part of that resource, when requested.

What does that mean in practical terms to the current board and the community at large?

To date, there have been 23 Past Presidents, 15 of whom are active members of the council, and we have had the privilege of serving Myrtle Trace, and just

like each one of you, possess abilities and experiences that can be shared with others.

Our involvement didn't end when our term expired. We just took on a different role, that of an advisor and counselor.

We meet on a quarterly basis and receive an update from the President of the HOA on the status of Myrtle Trace, and if we are called upon to offer an opinion

and assistance in resolving an issue, we do so, as we feel our previous roles give us an insight that can be beneficial.

This event also allows us to find out more about your new neighbors and what talents they bring to Myrtle Trace. At this get-together we ask them to fill out

a "Meet Your New Neighbor" form, which we place in the News and Views.

Our hope is that they feel welcomed, understand what a unique community we are, and how their talents can make a difference to Myrtle Trace.

As mentioned previously, we've had the privilege of serving as presidents of this community and we hope we've made a positive impact, not because of any

special abilities, but because we said yes to a need.

You can do the same. You don't have to serve on the Board, or even a committee, although we're always looking to fill those roles. Get involved, whether

it's attending a Board Meeting or an activity at the clubhouse. There's any number of places where you can offer help. This is your community, and it's only

as good as what each resident puts in to it.

Board received a detailed report from the Lake Preservation Committee, which summarized the results of two year study of our retention ponds

and included specific recommendations.

From this two year study the Board established a Lake Preservation Action Committee which was charged with developing and implementing a

plan for dredging our lakes.

The addition to the Clubhouse was completed and the storage areas rearranged making each area more efficient and safer.

Board developed a budget for 2018, without an increase in monthly homeowner's dues.

There were two Listening Sessions, one in May and one in November. We now have included "Resident Participation" as part of our monthly

Board meetings. This enables the Board to address and research resident concerns in a timely manner and will serve as a monthly listening session.

Replaced an outflow pipe on Burning Ridge Road.

Replaced the sidewalk from the pool area to the Clubhouse parking lot.

☐ Fixed a drainage problem off Myrtle Trace Drive.

Revision of ARC, and Property Guidelines and publication of them along with Board/General Policies and Article VII of the covenants were

placed in a 3-ring binder making it easier to locate information and is a more cost effective means of updating any of the above.

GOALS FOR 2018:

A quiet hurricane season. Can't promise that but hope that is the case.

Begin dredging our unhealthy retention ponds. In 2018 we hope to dredge the following: Oriole; Sparrow; and drainage area of Cormorant of

Wedgewood Drive.

in 2013 a committee was established to develop a plan for renovating the clubhouse. The final plan consisted of several phases and many of them

were implemented. However, one phase, the kitchen area, was only partially completed. In 2018, a committee will be formed to revisit the

kitchen area and submit to the Board some options, plans and related costs for completing the kitchen renovation in 2019.

myrtle Trace continues to be the community we have come to know and love and will remain as such with the continued efforts of our many

talented, dedicated, and resourceful volunteers.

UNITY has been the emphasis. The biggest asset in Myrtle Trace is you, the members of this community. It is because of your willingness to SERVE that

Myrtle Trace continues to be a self-governed community. If you believe it is important for and you desire Myrtle Trace to continue to be self-governed, please

stand. (Everyone in attendance stands). Thank you, again we see UNITY. We are united, we ALL IN, we all desire to see Myrtle Trace continue to be self-

governed. Okay, but here comes the hard part. Are you willing to commit yourself to seeing Myrtle Trace remains self-governed? Are you willing to serve in

various capacities? Yes, many are willing to commit to serving on the Activity, ARC, or Property Committee and/or offer their expertise when a special

project is being done. And believe me, for that we are most thankful. However, there is one area people are hesitant to commit themselves to, serving on the

Board. This is critical if you really want to have Myrtle Trace stay a self-governed community. Serving on the Board is only a three year commitment to

helping Myrtle Trace. We have people who have committed up to four times as many years serving on a committee. PLEASE, think hard about this, we need

people to govern Myrtle Trace, to work with committees, to develop a
